Dartmouth-Hitchcock Health and GraniteOne Health Participate in Public Forums on Combination to Create New Hampshire-based Health Care System

Forums mark important next step in seeking regulatory approval

Lebanon & Manchester, NH (October 6, 2021) – Continuing the process that began in early 2019, <u>Dartmouth-Hitchcock Health</u> (D-HH) and <u>GraniteOne Health</u> (GOH) will share details around the proposed combination of the two health systems at three public forums hosted by the New Hampshire Attorney General's Charitable Trusts Unit (CTU). Forums will take place Wednesday, October 6, from 4-6 p.m. in Peterborough; Thursday, October 7, 2021, from 6:30 – 8:30 p.m. in Manchester; and Thursday, October 12, from 6 – 8 p.m. in Wolfeboro. Sessions will be conducted in a hybrid format, with options to attend in-person or virtually via Zoom.

During the forums, New Hampshire Attorney General John Formella and CTU Director Thomas

Donovan will accept comments from the public on the proposed combination.

"This combination is centered on improving lives and creating healthier outcomes for our patients throughout New Hampshire, through building capacity in Southern New Hampshire, strengthening support for rural hospitals, making strategic investments, and coordinating care to meet patient needs in the right place at the right time," said Joanne M. Conroy, MD, CEO and President of Dartmouth-Hitchcock and Dartmouth-Hitchcock Health. "This is especially true in the critical area of behavioral health and substance use disorder treatment services, where we will invest tens of millions of dollars to add providers, improve access and integrate services across all areas of care."

In January, 2019, D-HH and GOH signed a Letter of Intent to combine the two health systems, followed by the signing of a <u>Combination Agreement</u> in October, 2019. The combined non-profit health system will build on more or than 15 years of existing successful clinical collaborations and community engagement, and will meet the growing demand for seamlessly-integrated primary, specialty, ambulatory, and inpatient care throughout the region. The result will be a high-quality, lower-cost, New Hampshire-based alternative to out-of-state providers.

"Although the process was slowed by the COVID-19 pandemic, our teams have pressed forward with diligence and patience amidst significant challenges," said Conroy. "In the past several years, New Hampshire's health care landscape has shifted significantly, and the pandemic further illustrated the need for health care organizations to be strong, nimble and responsive. Swiftly deploying our robust telehealth technologies, for instance, allowed our providers to continue seeing patients in even the most rural corners of the state until it was safe to return to in-person visits."

Once approved, D-HH would combine with GOH's three hospitals – Catholic Medical Center in Manchester, Huggins Hospital in Wolfeboro and Monadnock Community Hospital in Peterborough.

"Even before the pandemic, health systems were challenged with changing the way we do business to meet the increasingly complex needs of the communities we serve," said Joseph Pepe, MD, CEO of GraniteOne Health. "In New Hampshire, that means being able to offer the same access to care and technology wherever our patients need it. Combining our systems will allow us to do that. Together, we will be able to operate more effectively and efficiently, expand capacity, and enhance services across all the hospitals in our systems and in our communities to meet growing patient demand."

The combined and integrated system will transform health care delivery in New Hampshire while maintaining members' local identities, traditions and community commitments, including the distinct Catholic model of health care provided by Catholic Medical Center. All organizations within the combined system will also retain local leadership.

In September, 2019, the Most Reverend Peter Libasci, Bishop of Manchester, issued a *nihil obstat*, or <u>declaration of no objection</u>, allowing the Combination to proceed. The Bishop's declaration was a significant milestone in the approval process, and paved the way for the health care systems to submit their application for review to the CTU and Consumer Protection Bureau, as well as to the Federal Trade Commission for review and approval.
